The undersigned Respondent hereby submits to Milwaukee County ("County") the Proposal enclosed, to develop, implement, and maintain an Airport Voice Recorder System for General Mitchell International Airport ("Airport") based upon all terms and conditions set forth in Official Notice No. 6328 including attachments and addenda.  6. This Proposal may be withdrawn by requesting such withdrawal in writing at any time prior to the date and time responses to the RFP are due to be submitted to the County, as set forth in the RFP documents ("Proposal Due Date"), but may not be withdrawn after such date and time.
 7. The County reserves the right to reject any and all proposals and to accept that proposal which in its subjective judgment will provide the best level of service to the traveling public.
 8. This Proposal is valid for a minimum period of one hundred twenty (120) days subsequent to the Proposal Due Date.
 9. All costs incurred by Respondent in connection with this Proposal shall be borne solely by Respondent. Under no circumstances shall the County be responsible for any costs associated with Respondent's submittal.
 10. Respondent hereby warrants that:
 - a) Respondent has not in any manner directly or indirectly, conspired with any person or party to unfairly compete or compromise the competitive nature of the RFP process; and
 - b) The contents of this Proposal as to rent, terms or conditions have not been communicated by the undersigned nor by any employee or agent to any other person engaged in this type of business, prior to the official opening of this Proposal.
