Acceptance of Security Responsibility Statement

I viewed the General Mitchell International Airport Security Training video ("Training"). I have been afforded the opportunity to ask questions about this Training and received answers to those questions.

In accordance with this Training, I will:

- Abide by all the provisions as they are explained in this Training and in future updates as Milwaukee County; or my employer provides them to me.
- Display my Airport ID on the outermost garment while in a Security Identification Display Area (SIDA).
- Properly access, and secure after me, only those areas that are authorized to me by my employer, for whom I am performing duties at that time.
- Immediately challenge and/or report anyone I observe in a SIDA that is not displaying an Airport ID.
- Properly escort persons assigned to me and immediately report any security violations to MKE Airport Operations at (414) 747-5325.
- Return my Airport ID immediately upon termination of employment, badge expiration or change of access requirement. I must return my airport ID if convicted or found not guilty by reason of insanity of a disqualifying crime listed in Title 49 CFR Part 1542.209. I must surrender my Airport ID upon request to my employer, authorized airport representatives, law enforcement, or federal agencies.
- Comply with any inspections or search of me or my accessible property by authorized airport representatives, law enforcement or Transportation Security Administration (TSA).
- When I enter or exit an elevator to the Secured Area or Sterile Area, I must present my Airport ID and receive a green light at the card reader to gain access. All occupants must verify access approval from all individuals. When exiting the elevator, I must verify the doors are fully closed.
- SCREENING NOTICE: Any employee holding a credential granting access to a Security Identification Display Area may be screened at any time while gaining access to, working in, or leaving a Security Identification Display Area.
- All merchandise or items for sale or use by passengers that is brought into the Sterile Area shall be screened by the TSA, airport operator (or authorized representative) or Milwaukee County Sheriff's Office.
- No property may be handed to a passenger unless screened by approved measures and remains in the Sterile Area.
- When traveling, I am required to go through the TSA screening checkpoint to enter the Sterile Area. I will not use my Airport ID to bypass the TSA screening checkpoint. If I leave the Sterile Area, I must be rescreened.
- I will maintain direct control and accountability of all tools and TSA Prohibited Items that are used by me while in the Sterile Area. I understand that I may be subject to civil penalties and revocation of my Airport ID should I not maintain direct control and accountability of tools and TSA Prohibited Items. A list of these items is available at www.tsa.gov.
- I understand the MKE Airport Rules and Regulations are available on Milwaukee County's website and my roles and responsibilities therein.

By my signature below, I certify that I understand my security responsibilities under title 49 CFR Part 1540.105(a), including my responsibilities for unescorted access authority to the Sterile Area, Secured Area, and SIDA granted by possession of Airport ID Media. Any violations of this security responsibility may result in monetary penalties and/or suspension or revocation of unescorted access authority.
